## VII. **SELECTION POOL**

Nominations are held in the selection pool for three consecutive years. After those three years, if the individual has not been selected into the Hall of Fame, they become ineligible for consideration for one year. After that year, an individual can be re-nominated again with the filing of a new application packet.

## VIII. **RECOGNITION**

Inductees selected for inclusion in the Kansas Cooperative Hall of Fame will be recognized at a special ceremony. The recipient or their designee should be at the ceremony. Inductees will receive a plaque. Information and the photo from the plaque will be incorporated into the permanent display on the Kansas State Fair Grounds in Hutchinson, Kansas. Additional plaques may be purchased by the inductee or the sponsor upon request.
